THE DAY SCHOOL PROGRAM PROVIDES IN-SCHOOL SPECIAL EDUCATION SERVICES WHICH MAKE IT POSSIBLE FOR CHILDREN WITH DIVERSE LEARNING NEEDS TO ACCESS A JEWISH EDUCATION. THE GATEWAYS JEWISH EDUCATION PROGRAMS OFFER THEMATIC JEWISH EDUCATION CURRICULUM IN A SPECIALIZED STRUCTURED SMALL CLASS SETTING WHICH EMPHASIZES INDIVIDUALIZED ATTENTION TO STUDENTS AGES 4-18.
